THE GRAND JURY CHARGES:

Count 1

[Felon in Possession of a Firearm – Armed Career Criminal]

On or about January 15, 2014, in the District of Oregon, **DOUGLAS ANTHONY LYONS**, defendant herein, having been previously convicted of a crime punishable by imprisonment for a term exceeding one year, specifically:

- A. Assault in the Second Degree, Burglary in the First Degree, and Delivery of a Controlled Substance Schedule II, on or about August 8, 2005, in the State of Oregon, Multnomah County Circuit Court, Case Number 050130442;
- B. Felony Assault in the Fourth Degree (two counts), on or about November 16, 2001, in the State of Oregon, Multnomah County Circuit Court, Case Number 01-09-36416;

- C. Felony Attempt to Elude, on or about August 3, 1998, in the State of Oregon, Multnomah County Circuit Court, Case Number C9801-30438;
- D. Delivery of a Controlled Substance II and Supplying Contraband, on or about November 12, 1996, in the State of Oregon, Multnomah County Circuit Court, Case Number C960634857; and,
- E. Possession of a Controlled Substance II, on or about September 20, 1996, in the State of Oregon, Multnomah County Circuit Court, Case Number C9510-37959,

did knowingly and unlawfully possess the following firearm, to-wit: a Dan Wesson Arms Revolver, .357 Caliber, Serial Number 148250, which had previously been transported in interstate commerce, all in violation of Title 18, United States Code, Sections 922(g)(1) and 924(e).

Criminal Forfeiture Allegation
[Firearm Offense]

Upon conviction of the firearm offense alleged above in Count 1, **DOUGLAS ANTHONY LYONS**, defendant herein, shall forfeit to the United States pursuant to Title 18, United States Code, Section 924(d) and Title 28, United States Code, Section 2461(c), the firearm involved in that offense, to-wit: a Dan Wesson Arms Revolver, .357 Caliber, Serial Number 148250, and all the ammunition associated with the firearm.


